The CLUB has the right to charge credit card on file if account becomes delinquent. CLUB may deny or terminate membership for any lawful reason.

Memberships are non-transferable. CLUB reserves the right to change any and all aspects of membership. Any changes of membership will be in writing and mailed to MEMBER'S address on record. If these changes are unacceptable to MEMBER, MEMBER may cancel membership in writing.
